YINZER sped clear to dictate terms along the inside around the first turn, remained in hand around the far turn, responded when set down in the two path in upper stretch then held sway through the final furlong. GREEN LIGHT trailed along the inside, shifted to the two path in upper stretch, rallied to offer an inside bid for place at the sixteenth pole, vied with an outer pair for that position late and narrowly prevailed. COVERT LAW tracked two wide, then three wide around the far turn, bid for place in the four path in upper stretch, vied for that position through the final furlong but got nailed by an inner bidder at the wire. JOHNY'S RENDEZVOUS stalked closest to the clear leader and from the two path, chased while moving out to the three path in upper stretch, vied for place between bidders in the final sixteenth but yielded late. PIERRE laid off of the pace along the inside, then in the two path down the backstretch, moved to the four path turning for home before fanning to the five path in upper stretch but lacked a rally. VERSUS raced off of the pace in the three to four path and failed to factor. BABY MAX tracked along the inside, chased around the far turn and faded.
