POSTER tracked along the inside, then in the two path turning for home, shifted out to the four path to take aim outside of the top pair in upper stretch, sustained gradual progress to bid outside of the leader at the sixteenth pole and edged past. JUDGE DAVIS stalked two wide, bid outside of the leader turning for home, sparred in the three path while forging an advantage in upper stretch, led before meeting an outer challenge at the sixteenth pole, dug in but got bested. NOISES OFF saved ground off of the pace, then stayed on to edge show from outer rivals at the sixteenth pole. MIRANDA RIGHTS settled off of the pace two wide, shifted out to the five path in upper stretch and ran on mildly while hanging on his left ead. SMOKEY MANDATE showed the way along the inside, met an outer challenge turning for home, battled with that bidder in the two path in upper stretch but faded between horses in the final furlong. IDRATHERBEBLESSED broke a step sow, pursued from midpack in the three path, fanned out to the six path into upper stretch and gave way while hanging on his left lead.
