## Footnotes | View Glossary Of Terms

SMOLS was rated along the inside behind the leaders, made a move entering the the upper stretch and angled out nearing the furlong marker and closed up late to prove best. ORIGINAL SCORE rushed up early to set a pressured pace and shifted to the inside, showed the way and drew clear between calls but was nailed at the wire. COLT FORTY SEVEN was settled back on the inside, then eased out on the turn to the five path and made a late rally to get the show award. UNDERTAKER pressed the pace early from the three path along the backside and shifted closer to the two path along the turn, came about four wide passing the quarter pole and weakened in the lane. MORE THAN CUTE hit the starting gate while breaking inwards and settled back off the pace in the three path, came about six wide off the bend and made a mild gain. ROCKY LAGOON broke in the air and was off slowly, recovered quickly and tried to make a move between rivals nearing the five furlong marker and checked back, then settled on the inside and had no kick. NO MORE CALLS pressed the pace early in the two path and moved back to track the leaders around the turn, then came about three wide into the upper while fading. CHANCE ON ME broke in the air and was settled off pace, came between rivals around the five furlong marker and faltered. There was a TRAINER OBJECTION, the trainer of number two filed an objection on the one horse, after review there was no changes made.
