QUEEN IN THE DECK settled behind the pace in hand and while saving ground, moved closer along the rail late second turn, in some traffic into the straight, moved out a bit, set down when clear, kicked down the leader with some good late energy. TERRIE T dueled early inside, chased the leader up the backstretch, regained the advantage while continuing inside entering the stretch, clear a furlong out, could not contain the winner late clear second. DITCHED in mid pack while off the inside, in some traffic through upper stretch, improved position when clear the final furlong to annex the show. BELLA ESTRELA lacked speed outside, came five wide out of the final turn, rallied past the furlong marker to be in position to take the show, outkicked for that position late. NICKY JOLENE back off the pace inside, continued to save ground second turn, improved by cutting the corner into the stretch, also went flat in the late going. C. S. VIVACE off a step slow, devoid of early foot, improved position by passing mostly tiring rivals through the lane. ROCIO broke back and failed to threaten. REPAYNT rank while four wide into the first turn when contesting the pace, showed the way up the backstretch and into the final turn, gave way in the drive. STYLE AND PROFILE in the second flight while racing four wide, tired through the stretch. EMPIRE'S TREAT also in the second group for six furlongs, had nothing left for the stretch and backed up through the lane as well.
