MADDIE TEN settled well off the pace and off the rail, circled the field five deep from the quarter pole, picked up momentum six wide leaving the furlong marker, closed with a rush nailed the victory under the wire. BELLOFTHEBLUEGRASS hustled up out of the gate, staked the pace down the backside, quickened vied three wide around the far turn, inside foe through the final sixteenth, battled on gamely, nipped at the wire. MARILYN MOONROE broke alertly, exchanged bumps with inside foe into the first turn, vied between runners leaving the quarter pole, brushed DIAKONISSA once again approaching the furlong marker, finished willingly along the rail for the show. CITY TAAH saved ground off the pace into the far turn, advanced just off the rail leaving the quarter pole, clipped heels nearing the furlong marker, regrouped into the lane, surged on late to no avail after a rough trip. DIAKONISSA broke sharp, exchanged bumps into the first turn, vied inside in the three-way battle into the far turn, in tight quarters steadied along the rail nearing the furlong marker, lacked room late, stayed on despite a troubled trip. KILLY START moved up between foes around the first turn, roused four wide leaving the quarter pole, swung wide into the lane, came up empty. GONE WITH THE WYN raced off the pace three wide, tipped out five wide avoided trouble at the head of the lane, weakened final sixteenth. LET'S GO MO sluggish start, outrun. XANTHE saved ground off the pace, clipped heels fell nearing the furlong marker, walked off. THERE WAS A STEWRDS INQUIRY AND JOCKEY'S OBJECTION IN THIS RACE, THE RIDER OF DIAKONISSA CLAIMED FOUL AGAINST THE RIDER OF MARILYN MOONROE FOR INTERFERENCE APPROACHING THE EIGHTH POLE, AFTER THE JUDGE'S REVIEW, MARILYN MOONROE WAS DISQUALIFIED AND PLACE LAST.
