TRUTH AND JUSTICE broke very sharp, took command leaving the club house turn, coaxed along widened the margin leaving the quarter pole, running on the wrong lead held sway driving through the lane. CAN'T DENY THIS rated off the pace down the backside, upped the tempo circled five wide into the lane, rallied very late to nail down the place award. JOHANNA checked off heels into the first turn, slowly recovered position down the backside, inside pursuit leaving the furlong marker, stayed on willingly for the show. MY GIRL BRIDGIT bumped at the start, saved ground off the pace into the far turn, under pressure and running on the wrong lead, weakened through the stretch. SUNSET HOUSE bumped at the start, urged along chased the leader two wide down the back stretch, under pressure leaving the furlong marker, faltered through the lane.
