MY GREY HUMOR broke sharp, vied three wide into the turn, eased clear leaving the quarter pole, kicked away under strong handling. TALAVERA broke alertly, prompted the pace two wide into the turn, tipped out three wide for the stretch drive, chased on well late, second best. CAMELIA ROD broke a step slow, hustled up steadied along the rail nearing the three eighths marker, rail bid into the lane, willingly along for the show. LILLIPUT lacked speed out of the chute, chased inside off the pace leaving the quarter pole, came up empty. MAKAN broke slow, urged along three wide from the quarter pole, never threatened. THERE WAS A JOCKEY'S OBJECTION IN THIS RACE THE RIDER OF CAMELIA ROD CLAIMED FOUL AGAINST THE RIDER OF TALAVERA FOR INTERFERENCE NEARING THE THREE EIGHTHS MARKER, AFTER THE JUDGE'S REVIEW THE RESULT STOOD AOOICIAL NO CHANGE.
