DELIGHTFUL DIXIE bobbed at the bell, inside pursuit around the turn, took aim two deep into the lane, strong rally through the final sixteenth, in time at the wire. STRYDA sent hard out of the chute, wicked solo pace around the bend, running on the wrong lead through the lane, dug in gamely, conceded grudgingly. DISPOSITION chased the pace out of the chute, circled six wide into the lane, willingly up late for the show. FORGOTTEN GIFT in tight lost path out of the chute, pressed off the rail into the lane, inside rival through the final stages, improved lost the fight for the show money. ECHO SEVEN broke slow, pressed off the pace five wide leaving the quarter pole, had no late punch. DOLCE VELOCE broke alertly, chased four wide around the turn, weakened through the stretch. KLUYVAMEANANDNASTY lacked speed out of the chute, trailer around the turn, never threatened.
