MAGGIE'S GIRL broke alertly, vied three wide around the turn, battled in upper stretch outside GOLDEN CIRCLES, shook off that rival at the sixteenth, dug in valiantly inside PARTY TIME FOR ME, refused to yield under the wire. PARTY TIME FOR ME broke sharp, circled the leaders four wide leaving the quarter pole, had trouble switching leads in upper stretch, once she finally swapped over to the right lead, frenzied rally just missed. GOLDEN CIRCLES sent through the chute, vied between into the turn, chased the winner inside into the lane, no match from the sixteenth marker, stayed on willingly to save the show. THELASTSAY broke slow, chased inside into the turn, worked off the rail bid between runners into the lane, stayed on late, edged out for the show. EDY'S FLAME broke alertly, hard chase five wide around the turn, improved placing through the final sixteenth. REDHOTCHILIPHILLY broke a step slow, pressed three wide into the turn, shuffled off heels mid-way around the bend, could not recover into the lane, faded through the wire. PRIORITY ONE hustled up out of the chute, vied inside around the turn, no match from the furlong marker, weakened through the lane. STRYDA fractious in the gate pre-start, broke in air when the bell rang, pressed off the pace into the turn, faltered through the stretch. THERE WAS A JOCKEY'SOBJECTION LODGED IN THIS RACE, THE RIDER OF REDHOTCHILIPHILLY CLAIMED FOUL AGAINST THE RIDER OF PARTY TIME FOR ME AROUND THE TURN, AFTER THE JUDGES REVIEW THE RESULT STOOD OFFICIAL, NO CHANGE.
