COAL COUNTRY broke slow, rushed up out of the chute, cruised clear leaving the quarter pole, held sway driving. PALMARY broke slow, chased inside around the turn, angled out in upper stretch, rallied late for the place award. BEAUTY OF THE NILE broke slow, saved ground off the pace into the turn, inside rivals through the final sixteenth, came home willingly to nail down the show prize. HOLY COFFEE broke sharp, pressed two deep leaving the quarter pole, running on the wrong lead, improved through the wire. TIERRA SANTA broke alertly, chased the leader three wide around the turn, fade through the final stages. GOLDEN CAN bumped at the start, raced off the pace five wide into the turn, had no late response. RAINBOWSUNSUNSHINE pinballed at the break, roused on between runners into the turn, weakened through the stretch. CRAFTY WINDSOR CAT bumped at the star, chased off the pace between runners into the turn, faltered through the lane.
