HIGH PAF broke sharp, cruised clear leaving the club house turn, unchallenged approaching the furlong marker, kicked away handily for the victory. DRINK THIS CUP broke alertly, drifted out blew the first turn, quickly recovered pressed on down the backside, two wide pursuit into the lane, chased on through the final sixteenth, held safe for the place. SOMESUGARNSPICE saved ground mid-pack, roused on leaving the quarter pole, cut the corner into the lane, stayed on willingly for the show. GIRVINIZED reluctant to load, broke a step slow at the bell, pressed three wide down the backside, under pressure upper, had no late punch. GILDA'S GIRL saved ground off the pace, chased inside leaving the quarter pole, came up empty late. HEART'S COMPASS saved ground well off the pace, never factored. CHARGE NURSE tardy start, raced off the pace four wide into the far turn, never threatened. THERE WAS A TRAINERS OBJECTION LODGED IN THIS RACE, THE TRAINER OF CHARGE NURSE CLAIMED FOUL AGAINST THE RIDER OF SOMESUGARNSPICE FOR INTERFERENCE LEAVING THE STARTING GATE, AFTER THE JUDGE'S REVIEW THE RESLUT STOOD OFFICIAL NO CHANGE.
