AUTHENTIC APPEAL stalked the pace around the first turn, methodically inched up down the backside, captured the pace setter nearing the quarter pole, widened the margin into the lane, held sway under steady guidance. LIL JERSEY GIRL rated just off the pace down the backside, four wide pursuit of runaway winner into the lane, closed in willingly for the place. ELUSIVE SIONNA settled off the rail mid-pack down the backside, gaining momentum angled inside in upper stretch, improved position through the final stages. FOX FIFTY EIGHT trailer down the backside, cut the corner into the lane, evened out through the final sixteenth. OUT OF MIND saved ground well off the pace, clean rail trip leaving the furlong marker, had no late punch. PEACEFUL UNION raced well off the pace and off the rail down the backside, steered out six wide upper, had no late response. GOGO'S MOJO urged along four wide to keep pace down the back stretch, weakened through the lane. ONE HIT WONDER bumped at the start, pressed between runners off the pace into the far turn, retreated through the stretch. AVALANCHE IS COMIN sent into the first turn, set a swift solo pace down the backside, collared leaving the quarter pole, faltered through the lane. MAMAWASAGOGOGIRL bumped at the start, eased into the first turn, left the track via the equine ambulance.
