RHYTHM 'N BLUES rated kindly into the backside, swept by-quarter, drew away. NEVERPOPTHECORK raced well off the pace and off the rail, four wide willingly. DIRECT APPEAL saved ground mid-flight, worked between upper, evenly show. BIG JOE B pressed the pace into the backside, chased inside up, no kick. RAINY SKIES outrun down the backside, by-faders late, no real threat. CAP COM raced off the pace four wide, chased from quarter, no late impact. TALKLESSWORKMORE hustled up set the pace into the backside, steady fade upper. KAYLEE'S SPITFIRE chased the pace around the first two turns, steadily weakened.
