WHINNY MISS LYNNY broke sharp, stalked the pace around the first turn, took up the fight three wide when BEVERLY CRUSHER forced the tempo leaving the half mile marker, shook that rival off approaching the quarter pole, unchallenged into the lane, widened the margin under very mild urging. WHISKEY BREW broke a step slow, rated kindly well off the pace into the far turn, swung out six wide for clear run into the lane, under willingly for the place. KELSEY HILL GIRL settled well off the pace three wide, advanced outside rivals around the far turn, took aim five wide into the lane, one paced through the final stages, held clear for the show. JUSTICE YOU SAY broke sharp, urged along held inside position up close around the first turn, took back off the vying leaders down the back stretch, called up leaving the quarter pole, had no late response. INCENDIARY jostled lost path fighting for position soon after the start, saved ground off the pace into the far turn, weakened through the stretch. SUPER WICKED exchanged bumps soon after the start, found a clean pocket along the rail down the backside, blocked by fading rival around the far turn, could not regain momentum, came up empty. BEVERLY CRUSHER ridden out around the first turn, vied inside into the far turn, under pressure gave way leaving the quarter pole.

JUBA'S NOTION put to task soon after the start, took the lead and dictated the tempo on a solo pace into the far turn, held sway driving through the final sixteenth. LOGSTRADAMUS away in good order, pressed four wide into the far turn, unable to switch leads through the lane, churned on through the final stages, held safe for the place. SHARPASADIAMOND pressed between runners leaving the first turn, in tight quarters shuffled out of position approaching the three eighths marker, regained momentum leaving the quarter pole, four wide through the lane, rallied late to claim the show money. YANKEE DOODLE KID urged along inside around the first turn, held rail position chasing the leader into the far turn, running on the wrong lead through the lane, flattened out through the final stages. FORTUNATE SON tossed head broke slow at the bell, urged along five wide to keep pace down the backside, came up empty through the stretch. ROCKET APPEAL saved ground well off the pace, had no late response. DIRECT THE SHOW very slow into stride, settled off the pace three wide into the far turn, never threatened.

TORNADO WARNING settled well off the pace down the backside, took up the chase along the rail leaving the quarter pole, tipped out four wide into the lane, sustained rally through the final sixteenth, in time at the wire. I HOP ALOT broke sharp, hustled to the front leaving the first turn, set a solo pace down the backside, leader into the lane, dug in gamely along the rail through the final sixteenth, denied under the wire. GOLDEN BOSS MAN rated mid-pack outside rivals down the backside, took aim three wide around the far turn, running on the wrong lead stayed on willingly for the show. TIME TO GET IT rated around the first turn, chased inside leaving the quarter pole, clean trip through the lane, bid evened out through the final sixteenth. ELMINGTON in tight quarters refused rate between runners around the first turn, under pressure down the backside, steadily faded around the far turn. JUBA JACK raced off the pace three wide into the far turn, drifted out badly approaching the furlong marker, weakened through the stretch. BROADWAY'S WARRIOR lunged awkwardly at the start, never factored.
