ECHO SEVEN broke sharp, dictated the pace off the rail into the turn, shook off inside rival leaving the quarter pole, powered away convincingly for the score. GREAT ANDREI broke step slow, cruised up five wide into the turn, worked over to the rail leaving the quarter pole, knifed inside rival turning into the lane, rallied along the rail through the final sixteenth, second best. DELIGHTFUL DIXIE broke slow, rushed up chased inside into the turn, angled out five deep into the lane, chased on willingly in time for the show. BELLA MELA broke sharp, contested the pace along the rail into the turn, no match from the furlong marker, evened out conceded the show under the wire. MOLLY FACTOR broke slow, pressed between runners off the pace into the turn, had no late impact. MISS MENETES chased the pace four wide around the turn, running on the wrong lead, faded through the final sixteenth. COUNTRY CHERRY chased off the pace inside into the turn, weakened through the stretch. BELLA'S BREEZE hopped at the start, never threatened.
