BAIL IS DENIED broke sharp, vied inside around the first turn, shook off one foe as another challenger approached leaving the three eighths, sparred with that one into the far turn, worked free nearing the furlong marker, just as LIFE IS DAILY hooked him into the lane, refused to yield through the final sixteenth, determined drive held safe. LIFE IS DAILY rated off pace three wide down the backside, upped the tempo outside rivals leaving the quarter pole, tested the stubborn leader leaving the furlong marker, no match late, chased on second best. NOBLE RULING waited around the first turn, given the queue forced the pace battled outside BAIL IS DENIED into the far turn, no match for that one, stayed on willingly for the show. GIMMETHATSUGAR saved ground off the pace down the backside, sent to the attack four wide leaving the quarter pole, had no late impact. BAD LINEAGE outrun into the far turn, had no late response. MY BROTHERS ANGEL vied two wide around the first turn, unable to match strides with the winner, gave way around the far turn.
