NOCASHREFUNDS away in good order, set a swift pace along the rail into the far turn, stifled outside bidder leaving the quarter pole, under a stout drive leaving the furlong marker, drew away while never able to switch leads. ROBBIELIKESHIM tracked the top pair three wide to far turn, put to task approaching the quarter pole, tested the leader around the second bend, no match leaving the furlong marker, stayed on willingly for the place. BAD LINEAGE slow into stride, raced off the pace five then six deep, always well wide, came along late for the show money. LAWYER UP RILEY rated off the pace to far turn, called up four wide leaving the quarter pole, bid flattened out through the lane. DESTIN'S RAINBOW settled into stride off the pace and off the rail into the far turn, under pressure three wide through the lane, had no late punch. HURRICANE JIM saved ground from off the pace, never threatened. ESTRELLA FUGAZ broke sharp, pressed the pace two wide into the far turn, weakened through the stretch. DEFIANT GIANT slow into stride, roused three wide off the pace, gave way.
