SHARPASADIAMOND broke sharp, set a pressured pace along the rail into the far turn, stifled all bidders leaving the furlong marker, kicked away under strong handling through the wire. SHOW TIME ALLEN saved ground well off the pace into the far turn, angled five wide for the stretch run, rallied through the final sixteenth, up under the wire for the place. CANDY MAN MARTIN tracked off the top trio into the far turn, circled four wide loomed a threat leaving the quarter pole, no match through the lane, evened out late lost the place money at the wire. KVELLION contested the pace three wide into the far turn, pressed on two wide approaching the quarter pole, no match upper, flattened out through the final sixteenth. FUNKLE raced well off the pace and off the rail, three then four wide through the lane, mild late interest, had little impact. ABOLITIONIST hustled up around the first turn, pressed the pace between runners into the second bend, under pressure leaving the quarter pole, gave way through the lane. TOWN HOT sluggish into stride, trailer down the backside, never threatened. BOUNDFORABRUISIN chased off the top trio into the far turn, lost contact approaching the quarter pole, faltered through the lane.
