BAIL IS DENIED broke sharp, vied inside around the first turn, took control of the tempo when DIRECT APPEAL rated off into the second bend, sol tempo along the rail into the final turn, repelled all challengers through the lane, refused to give in late, held clear under strong handling. FLYIN MAYAN raced off the pace three wide into the far turn, angled inside nearing the quarter pole, altered course back outside for the stretch drive, rallied late to grab the place award. DIRECT APPEAL vied inside around the first turn, rated off the pace under the wire first time through, chased the leader two wide into the lane, no match leaving the sixteenth marker, stayed on willingly for the show. BAD LINEAGE outrun and well off the rail into the final turn, five deep running on the wrong lead, had no late impact. MR. DUMBLEDORE tracked off the pace into the final turn, hard ask loomed three wide leaving the quarter pole, faded through the stretch. LOVE IS WICKED tracked the pace through the first two bends, roused inside nearing the quarter pole, weakened through the stretch.
