GOGOGETEM broke sharp, vied then dueled two wide, battled upper, kicked on. HEART OF GOLD away in good order, vied then dueled inside, chased on well. GOING TO OMBRA up close three wide first turn, rated off backside, along show. PALACIO rated off the pace to far turn, bid between quarter, one paced. SAN SEBASTIAN broke step slow, roused hard five wide backside, empty late. TOWN HOT outrun into far turn, never factored through the lane. RIVERLEE roused off the pace two wide leaving the quarter pole, weakened. DENIZETTI chased between first turn, inside quarter, gave way lane. THERE WAS A JOCKEY'S OBJECTION IN THIS RACE, THE RIDER OF HEART OF GOLD CLAIMED FOUL AGAINST THE RIDER OF GOGOGETEM FOR INTEREFERENCE APPROACHING THE EIGHTH POLE, AFTER THE JUDGE'S REVIEW THE RESULT STOOD OFFICIAL NO CHANGE.
