GIMME A HOLLER broke step slow, rushed up, vied then dueled inside, chased on. INTENTION TO ZIP saved ground to turn, rail bid into the lane, chased evenly late. MISTER GRINCH chased three wide around the turn, flattened out to wire. GRONKSFLYINSEAGULL broke slow, roused on to turn, shied away greenly quarter. A REASON TO PARTY broke sharp, chased off pace six wide upper, empty stretch. BONDS REVENGE lacked speed to turn, bid four wide upper, weakened. JUNITO'S BOY very slow into the turn, never factored late. DONTCROSSTHELINE roused five wide to turn, under pressure quarter, faltered.
