EDY'S FLAME rated along under a hold near the inside, ridden while continuing an inside run near the quarter pole, shifted out four path to race from the outside of C'Mon Eileen in the drive and finished strongly to edge clear under steady pressure. C'MON EILEEN drifted around the first turn three deep, angled in back in early down the backstretch to race near the rail, led narrowly nearing the upper stretch but was overtaken in a game run. MASKEDANDMUMMED stalked the pace, raced four wide into the upper stretch and kept on to the wire. ORANGE CANYON settled to race mid pack early on, raced four wide around both turns and was even with no late bid. DIXIESPEPRMINTWIST lag early on to trail, saved ground and never threatened. TRUTH AND JUSTICE sent along early, packed out five wide into the first turn, ridden down the backstretch and was empty near the three sixteenths pole.
