GOLD FIBER roused hard out of the chute, chased inside quarter, needed more. COWBOY AT HEART sent hard between into the turn, three wide upper, flattened out. EL DE CHIREL hustled up chute, pressed four wide turn, weakened late. DREW D'ORO sluggish out of the gate, bid two wide off pace, no response. RED CANDY APPLE broke sharp, vied inside around the turn, retreated stretch. FU MAN SUE very slow into stride, outrun.
