DEFIANT GIANT away in good order, stalked the pace into the club house turn, quickened between runners down the backside, hooked up with BOX OFFICE approaching the final turn, vied inside that foe into the lane, kicked away late for the victory. BOX OFFICE stalked the pace three wide into the second bend, upped the pace vied outside DEFIANT GIANT into the lane, no match inside the sixteenth post, chased on well for the place award. FABELMAN tracked mid-pack three and four wide, took aim four wide from the quarter pole, closed in willingly for the show. SUMMONING DENIS slow into stride, roused off the pace three wide leaving the quarter pole, bid evened out through the stretch. MY BOY CLYDE raced well off the pace three and four wide, under urging from the furlong marker, came up empty late. TOBI WAN KENOBI saved ground off the pace, never threatened late. DIRBAS broke sharp, set the pace into the club house turn, collared mid-way down the backside, faltered through the wire. COMO up close inside into the club house turn, steadily gave way down the backside, eased home.
