A. L.'S BOY stalked the pace two wide into the far turn, upped the pressure vied around the second bend, forged a clear lead approaching the sixteenth post, held on under strong handling. DOUG'S TRIUMPH broke sharp, under constant urging inside down the back stretch, vied along the rail nearing the quarter pole, lost a step leaving the furlong marker, running on the wrong lead wandered through the lane, came again late second best. MY LUCKY ACE raced off the pace five and six wide, circled four wide upper, running on the wrong lead, along final stages for the show. TREE OF DEM raced off the pace three wide, put to task four wide leaving the quarter pole, by-faders improved placing late. TEX broke sharp, chased the top pair three wide into the second bend, gave way through the stretch. GO LONG veered out start, recovered chased the pace four wide down the backside, weakened through the lane. TOM'S GOLD hesitated at the start, trailer into the far turn, never factored. BUKOVEL saved ground towards the rear, never threatened. RING FUND saved ground mid-pack into the far turn, faltered through the lane. ROYCES RIDE chased the pace between down the backside, eased from quarter, walked off.
