DARE TO COMPARE contended the pace along the rail, turned back a challenge from BRODYS SOUVENIR and kicked clear. BRODYS SOUVENIR pressed the early pace outside of DARE TO COMPARE, dueled outside and lacked the kick needed. DREAMING D'ORO bumped leaving the gate, saved ground inside, and bid belatedly. PRINCESS FAVE was three to four wide in the first turn, chased in the final turn and flattened out in the stretch. CARAVALLA mild late bid. PRAIRIE SKY lacked a clear path leaving, chased four to five wide in the opening turn, and was unable to improve position late. B B BETH stalked three wide in the opening turn, and tired early. DIAMOND DI offered little.
