KANGAROO COAST broke sharply, stalked the pacesetters, rallied steadily and just held under a late drive. WESTERN SUNSET attended the pace along the rail, turned back a challenge from STONE HOUSE, and was nipped at the wire. SILENT COUNT settled at the rear, angled out nearing the stretch run, and finished with a powerful late surge, narrowly missing. STONE HOUSE contested the early pace, moved up alongside WESTERN SUNSET to challenge the lead, and lacked the rally required. WRIT IN STONE allowed to settle off the pacesetters, and lacked a closing response. CHICKOUTTHEBIZZ bumped leaving, saved inside and failed to threaten in the drive. EITHERINORINTHEWAY chased to no avail. MAN AT THE PULPIT bumped away from the gate, attended the early pace, and faded. BRI'S BOY broke awkwardly, lost rider leaving the gate, did not finish and walked off. STEWARDS' INQUIRY-The Stewards conducted an inquiry into the start involving BRI'S BOY and, after review of the film, determined that BRI'S BOY received a fair start.
