MI AMIGO angled in gradually through the backstretch, then contested the pace outside of FORCED TO RUN, gained the advantage then drew clear. POUR HOUSE bumped leaving, raced near the back of the pack, and closed gamely late to score second place. FORCED TO RUN contended the early pace, was unable to move on with the eventual winner and faded. SWIFT KAHUNA swung out three wide at the head of the stretch, then yielded in the stretch. FROSTED KNIGHT broke inward into POUR HOUSE, sat just off the pacesetters, ranged up four wide in the final turn, and came up empty in the drive. PENICILLIUM unhurried early and lacked a bid. ARI READY fanned four wide and was done early. TRAINER OBJECTION- An objection was lodged by the trainer of FORCED TO RUN against the rider of MI AMIGO alleging interference in the stretch. After review of the film, the Board of the Stewards disallowed the objection and made no change.
