THE FRIENDLY FIRE drove clear late. FIRST FLASH THE MOON late rally. STREAKIN SNOW WAGON broke inward, and was outkicked. JB FAMES EASY EFFORT late bid. MR GHOST BUSTER fractious behind the gate, drifted inward into SPLASHY NIGHTRIDER, and flattened out. SPLASHY NIGHTRIDER was brushed between foes by MR GHOST BUSTER, and yielded. STEWARDS INQUIRY- The Stewards conducted an inquiry into the start of the race. After review, it was determined that MR GHOST BUSTER caused interference with SPLASHY NIGHTRIDER and was disqualified and placed sixth.
