WAGON BURNER 109 mild bid. LETHAL N ROJO steadied along the rail mid-stretch and yielded. STEWARDS INQUIRY- An inquiry was conducted into the stretch run. No change was made after review. JOCKEY OBJECTION- An objection was lodged by the rider of LETHAL N ROJO against the rider of SHE MY DULCE GIRL alleging interference in the stretch run. After review of the film by the Board of Stewards, no change was made.
