APPRECIATE TODAY stalked wide, fanned three wide leaving the backstretch, and prevailed under a drive. WHO IS broke in, bumping into PURSUE, causing a chain reaction, sped to the front, responded to threats at the head of the lane and was outfinished. SPARKLET was brushed in traffic, then jostled between foes, angled inside, causing interference to PURSUE, and closed gamely. HORATIO bumped sideways, leaving the gate, trailed the field, and lodged a mild bid. JUSTCALLMEJAMES pressed the early pace while four wide, and weakened in the stretch. PURSUE squeezed leaving the gate, chased along the rail, was bothered at the head of the stretch and closed late. PIONEER STORM KING squeezed at the start, hustled early, lacked running room, brushed SPARKLET, and came up empty for the drive. J DUTTON sat in range while four to five wide, and faded. CHAMBERS fractious in the gate, stalked from the rail, and tired early. JOCKEY OBJECTION- An objection was lodged by the rider of PURSUE against the rider of SPARKLET, alleging interference at the head of the stretch. After review of the film by the Board of Stewards, SPARKLET was disqualified and placed sixth for interference with PURSUE.
