INSEPERABLE CRUISE broke inward, bumping into IMA HOTT VERSION, and lacked a bid. TRAINER OBJECTION- An objection was lodged by the trainer of O LA DEE DA against the rider of RJS BOSS, alleging interference leaving the gate. After revie,w it was disallowed.
