PACIFICISLANDTIME went to the front to set an unchallenged pace and won going away. AUTHENTIC GALLOP prompted the pace from two wide but was no match for the winner. MAZING MARK raced off the pace from two or three wide, dug in late to save the show. CALL MY BANKER had to steady early then stalked the pace from the inside, made a mild rail bid in the stretch but was outfinished late. UXMAL raced in the middle of the pack from three wide but failed to menace. BUTLER CABIN was unhurried to the final turn then saved ground around to pass tiring rivals late. SHORTLIST was allowed to settle on the inside around the first turn then raced in the middle of the pack from two wide but was not a factor. CHANNELFORTYNINE raced wide throughout and was always back.
