DADDY'S GIFT shared the command to the turn then pulled away and was kept to task in the stretch. GABE'S POSSUM was steadied early then raced within striking distance from five wide down the backstretch, tipped in to three wide around the turn and made a late run to be second best. MY CHULUPA raced off the pace from two wide but fell back on the turn then made a rebid and was no match for the top two. THE BOYZ PRIORITY raced close up early while saving ground but dropped back on the turn, made a late rail bid to improve position. GAME PORT stalked the pace from five wide down the backstretch but failed to menace. QUINNSALTYOFFICER shared the command to the turn and tired. C D'S WILD FIRE showed no speed and was not a threat. AMERICAN GUY was forwardly placed to the top of the stretch before giving way. JOCKEY GABE'S POSSUM CLAIMED FOUL AGAINST DADDY'S GIFT FOR ALLEGED INTERFERENCE AT THE START, AFTER A STEWARDS REVIEW THE CLAIM OF FOUL WAS DISALLOWED AND NO ACTION WAS TAKEN.
