THE BOSS SOSS stalked the pace from two wide around the first turn then moved up to take command at the quarter pole, pulled away to prove best. HE'S SUPER WICKED shot away to take a clear lead to the seven sixteenths before being overtaken but kept on to be second best. REGATTA BAY was forwardly place from two wide to the final turn then tipped out to three wide in upper stretch to make the late gain for the place. THROWIN' SHADE raced in the middle of the pack around the first turn then made a middle move down the backstretch and gave a late kick in the stretch to improve. PITCH AND RUN raced off the pace while saving ground through the final turn then tipped out to two wide in upper stretch but lacked the late response needed. PURRRFECT RHYTHM was allowed to settle near the back down the backstretch while racing wide throughout and passed tired ones. GOBOT was always back and not a factor. GAME AND GORMLEY was unhurried to the final turn then made a mild three wide bid but was never close. GIFT GIVER raced close up on the pace around the first turn then steadily faded and was outrun. THE THIMBLE raced in the middle of the pack to the final turn then was eased, distanced and walked off.
