DEAL EM JUSTICE sped away from the gate to a pressured pace to the turn then drew clear to prove best. VALID DEELITE race in the middle of the pack down the backstretch then made a four wide bid on the turn for the late rally to be second best. PASKETEE was forwardly placed to the turn then moved up around the turn to take a run at the leader but was outfinished. THEBOYZ WARNING stalked the pace from five wide moved up slightly before the turn and flattened out. LIVE AFFAIR showed no early speed, moved up from three wide on the turn for a late run but was not enough. QUIK PUNCH raced in the middle of the pack and failed to menace. FOXTROT HARRY was allowed to settle near the back around the first turn then steadily advanced to rally for the show. CASTLE ISLAND stalked the pace from four wide down the backstretch then made a mild bid on the turn to improve position but was outfinished late. BUTLER CABIN was unhurried around the first turn, moved between rivals near the three furlong marker, saved ground around the final turn and passed tiring rivals. THE THUNDERER tracked the leader from the inside to the top of the stretch then made a two wide bid at the leader and took the lead near the sixteenth pole and fended of the late surging rival to win the nod. IRON IN THE FIRE prompted the pace from three wide down the backstretch then fell back slightly on the final turn but made a rebid for the late surge and just missed. BIND FAITH hustled to a clear lead to the top of the stretch then started to weaken and was collared near the sixteenth pole and tired. SAM'S PROMISE trailed the field to the first turn then moved up the rail to settle in the middle of the pack down the backstretch, made another rail bid on the final turn but faltered. KNICKS STORY raced in the middle of the pack from between horses but failed to menace. MOBSTER GUN raced in the middle of the pack from three wide but was not a threat. NAPOLEONIC CODE trailed the field after the first turn and was outrun.
