POPPA MAGIC stalked the pace from three wide to the final turn then moved up to take the lead near the eighth pole and drew clear. HEAVENLY DEAL was unhurried to the final turn then circled the field from five wide and made the late rally to be a clear second. SARAH'S RUNNER pressed the pace around the first turn then settled off the pace down the backstretch, moved up to engage the leader around the final turn but was outfinished and dug in to save the show. CUNIMBUS went to the lead to set most of the pace before being headed near the eighth pole and was outkicked for the show. INCHHIGHATAHUNDRED raced in the middle of the pack from three wide down the backstretch then made a four wide bid on the final turn but failed to menace. BEACH BLANKET raced off the pace while saving ground to no avail. SEVEN DIGITS raced near the back while saving ground but was not a factor.
