ANSLIE'S GUMDROP raced in the middle of the pack around the first turn then steadily advanced from four wide and took the lead near the three sixteenth pole and drew clear. BREWSTER COUNTY raced near the back around the first turn then steadily advanced from four wide through the final turn but was no match for the winner and proved second best. SELECTIVELY SWEET settled off the pace from the inside around the first turn then tipped out to two wide down the backstretch, made a rail bid on the final turn but lacked room at the top of the stretch and made late improvement. WON BRIGHT LIGHT raced near the back while saving ground to the final turn then circled the field from three wide on the final turn to make a late run but was not enough. ROBERTS REVENGE was forwardly placed from two wide on the first turn then moved up from three wide but was outfinished in the stretch. CHIEF EXPRESS raced four wide into the first turn, then raced wide down the backstretch and passed tired ones. NOWNOWDANCER went to a pressured lead to the first turn then inched away to draw clear on the backstretch but was collared near the three sixteenth pole and tired. TIFF WITH JIMMY rushed up to vie

for the lead from three wide to the first turn then chased the leader to the final turn and gave way. TIME TO CLOSE hustled along to press the pace from two wide to the first turn then slowly faded. PAPIRINGA stumbled and lost rider leaving the gate, walked off. STEWARD INQUIRY INTO THE START OF THE RACE, AFTER A REVIEW PAPIRINGA WAS THE CAUSE OF HER OWN PROBLEMS AND NO ACTION WAS TAKEN.
