KARA FLASH stalked the pace from the inside down the backstretch then moved up from two wide around the turn and took the lead into the stretch and drew odd. JADE'S WICKED DOLL pressed the pace from two wide to the turn then fell back slightly but kept on to be second best. TAPPER vied for the lead from four wide to the turn then fell back around the turn then made a late kick to save the show. FLORA BOUND raced off the pace from two wide before moving up around the turn but flattened out to be best of the rest. GO NORTH BOSS raced near the back while saving ground through the turn then tipped out to three wide in upper stretch and showed mild late effort to improve her position. CALL FERN trailed the field to the turn then moved up slightly from three wide on the turn, tipped out to five wide in upper stretch and passed tired one. SHOULDABEENACOWBOY bobbed leaving the gate then was bumped repeatedly and chased the field while racing wide for a dull effort. PERIPHERY bumped with rival leaving the gate then vied for the lead from three wide to the turn and gave way. SIERRA HILLS rushed to the lead before edging clear on the turn and tired in the stretch.

BEGFORFORGIVENESS stalked the pace from the inside down the backstretch then slipped through at the top of the stretch and won going away. FORSAKEN went to a clear lead around the first turn before being challenged near the three furlong marker and dueled around the turn, kept on to be second best. WHISKEY AND EASY tracked the leaders from three wide then moved up to engage the leader midway through the final turn and flattened out. LO LO'S LAUGHTER prompted the pace from two wide then moved up to engage the leader midway down the backstretch and dueled to midway through the final turn but was outfinished. EL MERO MERO raced in the middle of the pace from three wide down the backstretch then tipped out to four wide at the quarter pole but lacked the late response. BACKFIRE was unhurried around the first turn then moved up slightly but was not a threat. COUNTRY DEALS was always back.

GOTTA SCOOT bumped with rival leaving the gate then vied for the lead from five wide down the backstretch then chased leaders around the turn and held on for the show. BELARSEN pressed the pace from two wide to the three furlong marker before flattening out and finished evenly. WORDS FOR CAMILLE showed no early speed then moved up from three wide around the turn and made a mild rally. CUT N DANCER raced close up on the pace from three wide early then saved ground around the turn and was not a factor. STORM BEE bumped with rival leaving the gate then race off the pace from four wide early and slowly faded before being outrun.
