FIERCE CAT vied for the lead from three wide then bumped repeatedly with rivals near the three furlong marker, fell back slightly going into the turn then made a rail bid into the stretch and drew clear. THE PETITIONER was forwardly place on the inside before bumping with rivals near the three furlong marker, moved up from two wide on the turn but couldn't catch the leader and was outfinished to be second best. SEVERUS SQUALL showed good speed to set most of the pace before being collared near the sixteenth pole and was a clear third. GLORYLAND BAND raced in the middle of the pack, made a mild bid on the turn, dug in late to make a mild late improvement. ZYDECO TYME bobbed at the start then settled in the middle of the pack down the backstretch, made a mild bid on the turn while giving an even effort. ZONG'S TO BLAME trailed the field to the turn before lugging out around the turn, made a late run to pass a tired one. GREATIZLOVE raced close up on the pace from two wide before being bumped repeatedly near the three furlong marker, stumbled and was shuffled back while losing action in a troubled trip. DOES NOT COMPUTE raced near the back and was not a threat.
