LOVE SIZZLIN BLUE even try. BCMOONVISIONS no real threat. FAST DASHN DEVIL bumped early, no late kick. FM STREAKINGFORFIRST awkward start, pinched back, lost iron. THE TRAINER OF #1 FAST DASHIN DEVIL LODGED A CLAIM OF FOUL AGAINST #3 JTF SAN CORONA FOR INTERFERENCE IN THE EARLY GOING. AFTER VIEWING REPLAYS STEWARDS TOOK NO ACTION.
