TK SWEET EYES solid rally, just up. TUCKERS PRIZE speed, caught late. JRS CORONAS TOAST gamely for show. EYE ROCKIN ROLL closed fast, drifted in late, up for 4th. CANDY SCHEME even try, drifted out late, bothered foes. JJ APOLLITICAL SNOW off slow, late interest. LONESTAR RUNNER early try, faded. CANTCONTAINTHEPOWER bumped late, pinched back, steadied. GEAXUX PARTY GEAXUX bumped late, pinched back, steadied. SOLE TRAIN showed little. THE JOCKEY OF #9 CANTCONTAINTHEPOWER LODGED A CLAIM OF FOUL AGAINST #10 EYE ROCKIN ROLL FOR INTERFERENCE IN LATE STRETCH. AFTER VIEWING REPLAYS STEWARDS TOOK NO ACTION ON THAT CLAIM OF FOUL. A STEWARDS INQUIRY WAS CALLED INTO THE RUNNING OF THE RACE AND AFTER VIEWING REPLAYS #7 CANDY SCHEME WAS DISQUALIFIED FROM 5TH AND PLACED 9TH FOR INTERFERENCE IN LATE STRETCH.
