AYDEN'S EDGE raced near the back in the early going, came around the first turn six wide, moved up between rivals around the final turn, split rivals down the lane, closed well and needed more ground. GIVE ME A TRY broke through the gates before the start, raced in the middle of the field, made a late bid and proved no match for the top two. AWESOME WILLIAM raced near the back in the beginning, saved ground around the second turn, made a bid down the stretch and was outfinished for third. GYPSY SQUALL raced near the middle of the pack and put forth an even effort. ABOUT THE BUSINESS dueled for the early advantage and faded down the home stretch. BABY ZONG vied for the early lead, saved ground and dropped back. WICKED TIMES raced within striking distance and was finished early. ONEMOTIME void of early speed and was outrun. DEPUTY DEAL got left at the start, was pawing, being unprepared and trailed throughout.
