BREWSTER COUNTY unhurried in the beginning, moved up strong on the outside around the second turn, made a wide rally and drove clear. BABY JANE void of early speed, moved up on the inside around the second turn, angled out at the head of the stretch, made a wide bid and was a clear second. TAKE HER AWAY lacked early speed, saved ground around the final turn, made a rail bid, proved no match for the top two, but got up for third. TALKABOUT pressed the pace, saved ground and lacked a late kick. GOOD BY FAITH raced within contention, forwardly placed throughout and weakened. GRIZMO went to the front, drove clear, saved ground and faded. PRETTYWELL STACKED raced within striking distance, finished early and was no threat late. AT FIRST LIGHT raced in the middle of the field, weakened and finished evenly near the back. BREAK OUT SISTER lacked early speed and was never close. TOO MUCH GUITAR raced within striking distance, dropped back and was outrun.
