DOUBLE EDGE SWORD broke in, vied for the early lead, drove clear around the turn, pulled away down the lane and proved the best. HELLADIC bumped at the start, challenged for the early lead, forwardly placed throughout, proved no match for the winner, but held on for second. HOLY STICK (CHI) bumped at the start, raced near the back, made a late bid and was outfinished for second. GRAZEN BOY void of early speed, made a mild bid, racing wide and was no real factor. ACE VENTURA (CHI) raced in the middle of the field and put forth an even effort. INDIA INK pressed the early pace, saved ground around the turn and faded. SUPREME CAPO always raced near the back and showed little. HUEY DUEY broke a step slow, shut off, racing in the back, moved up and dropped back down the final stretch. THE JOCKEY OF #4 HELLADIC LODGED A CLAIM OF FOUL AGAINST #7 DOUBLE EDGE SWORD FOR INTERFERENCE AROUND THE TURN. AFTER VIEWING REPLAYS STEWARDS TOOK NO ACTION.
