## Footnotes | View Glossary Of Terms

SAINT GABRIEL challenged on the front end, saved ground around the final turn, pulled away down the home stretch and proved the best. JEFFROW void of early speed, made a late inside bid, proved no match for the winner, but was a clear second. CHAD'S FLASHY WAYS raced near the middle of the field, came around the second turn on the outside, made a late bid and proved no match for the top two. DOCTORED DEAL lacked early speed, moved up on the outside around the final turn, made a bid and hung. PACIFICISLANDTIME lacked early speed, moved up on the outside around the final turn, finished wide and was no factor. CAUSEWAY BENNY showed brief speed, dropped back and was no threat late. MAJORITY OPINION raced within contention, saved ground around the final turn and faded. OTRA COSA dueled on the front end in the beginning, dropped back and was outrun.
