CAJUN AMI lacked early speed, moved up on the outside around the final turn, made a wide bid and drove clear. RANCH WATER vied for the early lead, saved ground, forwardly placed throughout, proved no match for the winner late, but held on for second. THE BOSS SOSS dueled for the early lead, raced close throughout and was outfinished for second. HOME VISIT pressed the early pace, weakened and was no threat late. IRON IN THE FIRE raced within contention, saved ground, faded and finished evenly near the back. TONTERIA void of early speed and showed little. COUNTRY DEALS pressed the early pace, dropped back and was done.
