WEAVER broke sharply, seized command, was challenged on the turn, responded to her cue leaving the turn, drew off in the stretch and was taken in hand through the final sixteenth. ROYAL MIST outrun early, commenced her bid on the turn, was swung five wide into the stretch, rallied but proved no match. ALBALI settled in the early going, was urged to improve on the turn, angled three wide into the stretch and kept on. YOLUNA was outpaced early but showed mild late interest. IT'S THE LAW BABY chased along the inside rail, was asked on the turn and lacked a rally. BANGKOK BLAZE ducked in at the start bumping DOE'S LEMONADE, forced the pace, led briefly on the turn but was empty in the stretch. DOE'S LEMONADE unruly in the starting gate, was slammed into at the start and failed to threaten.
