PLAUSIBLE DENILE advanced in the two path inside horses to bid for the lead leaving the turn, brushed with CYBERBEAST in upper stretch, went clear and held sway under energetic urging. TRIPLE PASS , swung outside about a furlong after the break, circled the turn four deep and rallied nicely. CYBERBEAST cruised to the front soon after the break, was kept in the three path on the turn, brushed with the winner in upper stretch and gave way in the drive. WORLD ON FIRE broke slowly, remained along the rail chasing the pace to the stretch and weakened.
