SOMME RIVER bumped with POWER AND GLORY leaving the starting gate, raced three wide the first turn, circled the far turn three wide, closed steadily outside WILL OF VICTORY, led late and drove clear. WILL OF VICTORY showed speed along the inner rail, held a clear advantage turning for home, drifted out a bit in mid stretch and finished gamely. RYLNSLOOKINGLUCKY showed speed outside WILL OF VICTORY and faded in upper stretch. POWER AND GLORY bumped with the winner at the start, swung wide in upper stretch and passed tired horses. AIBELL angled in early, stayed along the inner rail on the turns, swung to the four path in upper stretch and lacked the needed rally. CALL ME TONI , outside horses down the backstretch while in the two path, eased out three wide leaving the far turn and gave way in mid stretch. HALF A DECK stalked the pace, hugged the inner rail on the far turn was lightly steadied behind RYLNSLOOKINGLUCKY approaching the stretch and gave way. REHOBOTH AVENUE was outrun. An objection by the rider of HALF A DECK against RYLNSLOOKINGLUCKY for alleged interference near the five sixteenths pole was not allowed.
